You are hereby invited to register on the National Film and Video Foundation Supplier Database. **All the registered suppliers are also required to reapply to be included in and update the database.**

In order to comply with Treasury Regulations 16A, the Entity developed a supplier database to be used by the Supply Chain Management Unit.

The purpose of this database is to give all prospective suppliers an equal opportunity to submit **quotations** to the entity and to enhance transparency and equality. The database will also contribute to better administration and compliance with the PFMA and legal framework effective from 7 December 2011.

Below are mandatory details of official registration form that will assist in updating the departmental database.

Please note that a valid tax clearance certificate must be obtained from the South African Revenue Services (SARS) where the prospective service provider is registered for tax purposes. SARS will furnish the bidder with a Tax Clearance Certificate that will be valid for a period of **12 months** from date of issue. The original Tax Clearance Certificate, CIPC certificate and certified I.D of all owners must be submitted together with the application form and confirmation banking details. All suppliers are expected to go through a screening process. It's imperative that all contact details and email addresses are working efficiently. Failure to comply with these will invalidate your proposal. An original (Certified) BEE certificate is required. Copies will not be considered.

Failure to submit the **original and valid** Tax Clearance Certificate **will** invalidate the application. **It is imperative that suppliers read the application document carefully, complete it in full and sign it.**

4. Each person whose signature appears on the accompanying bid/proposal has been authorized by the bidder to determine the terms of, and to sign the bid, on behalf of the bidder;
5. For the purposes of this Certificate and the accompanying bid/proposal, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid/proposal in response to this bid invitation/request for proposal;
 - (b) could potentially submit a bid/proposal in response to this bid invitation/request for proposal, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder
6. The bidder has arrived at the accompanying bid/proposal independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid/proposal which does not meet the specifications and conditions of the bid/request for proposal; or
 - (f) bidding with the intention not to win the bid/request for proposal.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation/request for proposal relates.

³ **Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.**
9. The terms of the accompanying bid/proposal have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid/proposal opening or of the awarding of the contract.
